He was commissioned in 1985 after graduating from Union College and has served in various positions for the 21 years he has been in the United States Air Force. Last Year he served a six-month tour as the theater civil engineer in charge of all Air Force civil engineer forces in the entire Southwest Asia region to include Iraq and Afghanistan. He was stationed at the Combined Air Operations Headquarters for all coalition Air Forces at Al Udeid Air Base, Qatar, and traveled to Iraq, Afghanistan, Kuwait, and the United States Arab Emirates while serving in Southwest Asia. Lieutenant Colonel Terry Watkins gave a slide presentation on the time he spent in Iraq and Afghanistan with a question and answer period after the presentation.
