SCHEDULING PUBLIC HEARING ON PROPOSED LOCAL LAW AMENDING TOWN OF CORINTH SUBDIVISONS REGULATIONS

A motion was made by Councilman Major, seconded by Councilman Byrnes, and following resolution was

ADOPTED Ayes 5 Lucia, Brown, Major, Byrnes and Saunders Nays 0

WHEREAS, the Corinth Town Board (the "Town Board") is considering adopting a Local Law to amend the provisions of the Land Subdivision Regulations to require notice to nearby landowners; and

WHEREAS, Municipal Home Rule Law §20 requires the Town Board to hold a public hearing prior to the adoption of a Local Law;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF CORINTH, SARATOGA COUNTY, NEW YORK, AS FOLLOWS:

Section 1: Public Hearing; Notice - The Town Board shall meet on August 11, 2011 at 7:10 PM to hold a public hearing to hear all people who are interested in proposed Local Law No.2 of 2011 which would amend Chapter 112 of the Town Code, entitled "Subdivision of Land", to require that notice of any Public Hearings on an application for Subdivision Approval be mailed by certified mail, return receipt request to owners of all parcels located within 500 feet of any part of the property proposed to be subdivided. The Town Clerk is hereby authorized and directed to publish a Notice of Public Hearing in the *Glens Falls Post Star* not less than ten (10) days before the date of the public hearing.

Section 2: County Planning Board Referral – The Town Clerk is hereby further authorized and directed to send a copy of the proposed Local Law to the Saratoga County Planning Board for its review and advisory recommendation.

Section 3: Effective Date - This Resolution shall take effect immediately.

The question of the adoption of this Resolution was duly put to a vote on roll call which resulted as follows:

He said that they asked that a letter be sent to them outlining what the town has done and where the Town stands. Councilman Byrnes asked if the Town should send a letter to the tenants of the park telling them that the town will be proceeding to shut down the park and asked if the town code had any fines associated with the violation, Attorney Hafner said that he will look into both these questions and get back to the Town Board.
