RESOLUTION #148
ADOPTING LOCAL LAW NO. 1 OF 2013 AMENDING CHAPTER 55 OF THE TOWN CODE REGARDING DOGS AND OTHER ANIMALS

WHEREAS, the Town Board wishes to amend certain provisions of Chapter 55 of the Corinth Town Code, entitled "Animals", relating to fees, dog bites, dangerous dogs and nuisance animals; and

WHEREAS, proposed Local Law No. 1 of 2013 was prepared which makes these revisions; and

WHEREAS, the Board duly held a public hearing on proposed Local Law No, 1 of 2013 on April 11, 2013 and heard all interested persons;

NOW, THEREFORE, BE IT

RESOLVED, that the Board hereby adopts Local Law No. 1 of 2013 amending certain provisions of Chapter 55 of the Corinth Town Code, and be it

FURTHER RESOLVED, that the Board hereby authorizes and directs the Town Clerk to file the Local Law with the New York Department of State in accordance with the provisions of the Municipal Home Rule Law and acknowledges that the Local Law will take effect immediately upon filing by the Department of State.
