<u>Insurance Presentation</u>

Cassandra Martin presented an Employee Benefit Renewal with pricing for health insurance for Town of Corinth employees. Mrs. Martin summarized the premium costs and benefits of the present plan. Mrs. Martin told the board that if they renewed the present policy the cost would go up 7.9%.

Councilman Collura asked questions about changing to the HRA that was discussed last year. Mrs. Martin discussed the HRA Plan.

RESOLUTION #245 RESOLUTION TO INCLUDE VILLAGE OF CORINTH WITHIN TOWN OF CORINTH AMBULANCE OPERATING TERRITORY

WHEREAS, the Town has a current EMS Operating Certificate which will expire on February 28, 2015; and

WHEREAS, the Village of Corinth also has a current EMS Operating Certificate which will expire on February 28, 2015; and

WHEREAS, the Village contracts with the Town of Corinth Ambulance Service to provide ambulance service within the Village; and

WHEREAS, the Village of Corinth and the Town of Corinth wish to combine their ambulance authorities and amend the operating certificate to create a single ambulance service; and

WHEREAS, the Village Board of Trustees has adopted a Resolution rescinding its Resolution to establish and operate a municipal ambulance service within the Village under Public Health Law Section 3008(7)(a) and requesting the Town to amend its ambulance operating territory to include the Village;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The Town Board hereby agrees to amend its ambulance operating territory to include the Village and the Town Supervisor is hereby authorized and directed to submit a written request for territory amendment to the Department of Health that includes a copy of the Village Board's Resolution.
- 2. Upon receipt from the Department of Health of an amended Ambulance Service Operating Certificate identifying the Town's authorized operating territory as "Town and Village of Corinth", the Town Supervisor is hereby authorized and directed to make any required notifications, and submit copies of the amended Ambulance Service Operating Certificate, to the patient billing service bureau.
