This November 19, 2013 is the 150<sup>th</sup> anniversary of President Abraham Lincoln's Gettysburg Address.

The beautiful Civil War memorial in front of your town hall is a lasting tribute to all the men and women who have served in the military from your town.

Most people probably never look at the back of the memorial. There is a beautiful Gettysburg Address. All these plaques are different. I have never found any two exactly the same.

Many years ago, I found the original tombstone of Phillip Rice at Stan's Flea Market in Wilton. Your town accepted this stone and has placed it in a honored section of the Corinth Rural Cemetery. Mr. Rice is the first man to die in the Civil War from Corinth and for whom the local Grand Army of the Republic Post was named.

The Department has received and accepts the surrender of the Corinth Ambulance Service, Village of Operating Certificate per resolution number 34 dated October 23, 2013.

The Corinth Ambulance Service, Village of Operating Certificate is no longer valid effective November 19, 2013. Your municipality is no longer recognized as an EMS agency. The agency code number previously issued to your service is no longer active and may not be used to identify your ambulance agency on Patient Care Reports (PCR) or to obtain reimbursement for EMS certification training. The Department has added, per the aforementioned resolution, the village to the operating certificate for Corinth Ambulance Service, Town of.

Should the village wish to operate an ambulance service at some point in the future, you will need to submit an application to the Regional EMS Council and prove that there is a demonstrated absence of ambulance service in your area.
