The Town Board of the Town of Corinth held a Public Hearing on the Preliminary Budget on November 7, 2013 at 4:30 PM at the Town Hall.

The meeting opened with Town Clerk Farr reading the Legal Ad published in the Post Star on October 30, 2013.

Supervisor Lucia read the following:

**Public Budget Hearing**

**November 7<sup>th</sup>, 2013**

**The 2014 Budget**

The Budget Process has formally ended for the upcoming year. But unfortunately the 2015 process starts tomorrow. We monitor every day with the bookkeeper, town auditor, payroll clerks and Town clerk's office, to make sure things are on target, and the monies come from and go to, the right accounts, to make sure our books balance, and do we need to change things come next fall for 2015.

The economy, plays a huge part in where our budget goes, then when you add the state mandates, the rising costs of fuel, electricity, propane, asphalt, and Health and Property Insurance, you have your work cut out for you.

On the revenue side we hope for more sales tax, mortgage tax, grants and fees, to offset our expenditures.

This year, before the process started, we took the time to chat with all employees' that wanted to talk to the board. We get to know them better and also get to know what is needed to make their particular departments function better for the public.

The budget officer and the Town Board spend a lot of hours, putting together this preliminary budget, with being fair to taxpayers while we do it.

**The Budget we are presenting today has a Town Tax rate of \$1.527175 per thousand, compared to last year of \$1.520281,**

**In Special Districts, the Highway DB has gone down from \$1.69 a thousand to \$ 1.387258, The B Fund has gone down from .40 cents to .38 cents a thousand, and all water and lighting districts remain stable.**

**The Special District, Fire Protection, has jumped from .960568 per thousand, to \$1.099253. This includes our regular fire contract with the Village for Town Fire Protection, and a onetime charge of \$30.000, for our half of the new fire department water rescue boat,**

**The budget includes a 2% employee raise across the board, and some individual adjustments for job duties and descriptions. We are adding one more full time paramedic, making two town employees. The rest remaining partime. The cost of a medic is almost completely covered by revenues from outside municipal contracts.**

**We will be getting a much needed new furnace at Town Hall, Highway will be adding a couple new dump bodies**

**Any raises next year will be given on a merit system, after Employee reviews throughout the year,**

**If you were to compare the tax rate per thousand for the main taxing accounts, A,B,DB, and Fire Protection, Last year was \$4.59 per thousand and this year \$4.38 per thousand.**

**As budget Officer, I feel we are presenting a very fair budget, with today's costs. We are planning on more revenues from sales taxes and the like. We also have used some fund balances, which we need to be careful of, as we don't want to cut them to short.**

**Again we are quite a ways under the state Tax cap of a 2% raise in taxes, if we went up anymore, we would be forced to raise taxes, and this board pledges to not do that as long as it is financially fesible.**

**We also have to monitor this closely as not to have to raise taxes too much higher and still maintain our quality of services.**

**We want to thank the Department heads and employees for always being fiscally responsible throughout the year.**

There being no one in favor or in opposition to the proposed Preliminary Budget the Public Hearing was closed on motion of Councilman Halliday and seconded by Councilman Byrnes.
