CORINTH TOWN BOARD
RESOLUTION ADOPTING LOCAL LAW NO. 3 OF 2014
RELATING TO ON-SITE SEPTIC / WASTEWATER TREATMENT SYSTEMS
IN THE TOWN OF CORINTH

WHEREAS, Town Board wishes to clarify and highlight the New York State Department of Health requirement for involvement of a licensed design professional in the design, planning and installation of repair and replacement of residential on-site septic / wastewater treatment systems in some cases; and

WHEREAS, proposed Local Law No. 3 of 2014 was prepared which provides for these requirements; and

WHEREAS, the Board duly held a public hearing on proposed Local Law No. 3 of 2014 on November 13, 2014 and heard all interested persons; and

WHEREAS, the Board determined that adoption of Local Law No. 3 is an Unlisted Action under the State Environmental Quality Review Act ("SEQRA") and authorized preparation of Part 1 of the SEQRA Short Environmental Assessment Form ("EAF"); and

WHEREAS, the Board considered Part 1 of the EAF and completed Part 2 of the EAF;

NOW, THEREFORE, BE IT

RESOLVED, that the Board hereby finds that adoption of Local Law No. 3 will not have a significant adverse impact on the environment and authorizes the filing of the EAF as a SEQRA Negative Declaration - Notice of Determination of Non-Significance with respect to the action; and be it

FURTHER RESOLVED, that the Board hereby adopts Local Law No:3 of 2014 relating to on-site septic / wastewater treatment systems in the Town of Corinth; and be it

FURTHER RESOLVED, that the Board hereby authorizes and directs the Town Clerk to file the Local Law with the New York Department of State in accordance with the provisions of the

Municipal Home Rule Law and acknowledges that the Local Law will take effect immediately upon filing by the Department of State.

RE: "Town of Corinth Honors Veteran Hometown Heroes"


Thank you! From the bottom of my heart, THANK YOU!!!
