RESOLUTION AUTHORIZING SETTLEMENT OF PENDING ARTICLE 7 REAL PROPERTY ASSESSMENT CASES FILED BY INTERNATIONAL PAPER COMPANY

WHEREAS, International Paper Company ("Petitioner"), filed Article 7 Real Property

Assessment Review cases against the Town in 2012, 2013 and 2014 concerning the assessments on

its property located on Pine Street, more specifically identified by its Tax Map Number: 60.78-1-6.11,

and

WHEREAS, the terms of a proposed settlement have been negotiated with Petitioner, and

WHEREAS, the Town Assessor has reviewed the proposed settlement terms and finds them

acceptable, and

WHEREAS, the Village of Corinth and the Corinth Central School District have both

approved the proposed settlement, and

WHEREAS, it appears to be in the best interests of the Town to avoid the significant costs

and the uncertain outcome that could result if the litigation continues and goes to trial,

NOW, THEREFORE, BE IT

RESOLVED, that the Corinth Town Board hereby approves the proposed settlement of the tax

assessment cases filed by International Paper Company for 2012, 2013 and 2014 as follows:

1) 2012 Petition – to be discontinued by Petitioner; no reduction in assessed value

and no refunds.

2) 2013 Petition – reduce assessment from \$3,780,000 to \$2,950,000; pay refunds.

- 3) 2014 Petition reduce assessment from \$3,780,000 to \$1,267,000; Town and and County tax bills for 2015 to be based on reduced assessment (or pay refunds if bills are based on original assessment and taxes are paid based on original \$3,780,000 assessment).
- 4) 2015 Assessment Roll property to be assessed at \$950,000 unless buildings are constructed or the property is subdivided before the taxable status date (March 1st) for the 2015

Assessment Roll.

and,

BE IT FURTHER,

RESOLVED, the Town Board authorizes and directs payment of refunds of Town and Special District taxes for the 2013 Petition in accordance with the assessment reduction set forth above for that Petition. The Town Board also authorizes and directs payment of refunds of Town and Special District taxes for the 2014 Petition in accordance with the assessment reduction set forth above for that Petition if, and only if, Petitioner pays taxes based on the original assessment of \$3,780,000. Refunds shall be paid without interest, provided they are paid within sixty (60) days after Petitioner serves a copy of the filed Court Order approving the settlement, with Notice of Entry, on the Town and on the Saratoga County Treasurer, and

BE IT FURTHER,

RESOLVED, that the Town Board further authorizes and directs the Town Supervisor, Town Assessor, Town Clerk and/or Town Counsel to execute settlement documents and take any additional steps necessary to effectuate the proposed settlement in accordance with the terms of this Resolution.
