Q & A Don Rhodes/ Jason Matte:

Don Rhodes spoke about –

1. The existing problems the Village is having with the water meter contractors and how it is being handled and possible options for the town if the issues are not corrected.
2. How the messes are being cleaned up where there are multiple homes off of 1 line
3. Allen Rhodes Jr.- pay bills forever in agreement between owners and Town has option to waive application fee.
4. Moving prescheduled water shut off day to Wednesday because of Primary being held at Town Hall on Tuesday
5. Disturbed Lawns- most are in Villages right of way.
6. Freight house road area line replacement- hopefully being addressed under the clean water project grant.
7. Leak Studies- How and when they are done.

Jason Matt gave an overview of what TI Sales and their equipment has to offer the town. Don Rhodes clarified that their equipment has the capabilities to monitor water leaks within the house not from the main.

Little League:

Supervisor Lucia said he spoke to Sandy at the Office of the aging and she said that they were not allowed to use state monies for repairs to Town Buildings under the new guidelines. Councilman Byrnes said covering them is a good idea.

Supervisor Lucia informed the board that there were three applicants to be interviewed for Ida's job and that there has been a salary increase that has already been approved by Sandy at the Office of the aging.
