Adult Recreational Program

Supervisor Lucia said he received a phone call from a resident asking whether the Town was implementing the Adult Recreation program at the Corinth Central Middle & High school. Supervisor Lucia stated that this is a big hit with many residents during the winter months. It encompasses basketball, volleyball, dancing, yoga, and walking. He also stated they would need a director/someone to monitor the program. The pay would be \$13.18 per hour and could be 3-4 nights per week. Supervisor Lucia asked if anyone knew of someone to fit the position to let him know as soon as possible, as would need to submit the application at the school board meeting two weeks prior to the meeting in order not to delay it.

ZBA Cellular Tower

Supervisor Lucia received information from the Zoning Board regarding a cellular tower project in a R-1

Zoning district (four properties on the end of First Street in Corinth-Tax Map #73.72-1-19.122, 73.72-1-19.11, 73.52-1-39.2, and 73.52-1-34.15). In an email Albert Brooks wrote that the cellular towers are not allowed in R-1 districts and that the Zoning Board would have to go through the proper steps to obtain permission to erect a cellular tower on any one of the properties. Supervisor Lucia said a public hearing would take place.
