GRAHAME CHAMPAGNE:

Saratoga County Fire Advisory Board update:

Volunteers:

Volunteer issues are a problem across the country. The Governor put together a task force to come up with ideas for recruitment---set of recommendations.

Factors:

*Identified as a crisis, in 20 years NY State has lost 20,000 volunteer firefighters. This affects response time, getting equipment out, mutual aid is used in many situations.

*Increase in responsibility—not just responding to fires. Responding to accidents, hazmat, weather emergencies.

*Training has increased to 120 hours which is required for all volunteers and that does not include calls.

Recommendations:

*Enhance Fire fighter training through distance training but in person is always better. Could possibly use local schools for training.

*Provide benefits for volunteers, such as retirement plan, property tax relief, Etc.

*Research what other states are doing.

*Saratoga County provided \$2200.00 to each department for recruitment efforts.

Training Center:

*Issues with the smoke house, the building is worn out. Have received approval for a grant but have not received the funds. The building is closed until it is fixed.

*Pushing for funding for training.

Portable Radios:

*Some of the portable radios can no longer be fixed.

*New radios are expensive ranging from \$2,000 to \$6,000 for one radio

*The County provides mobile radios, but the individual Departments pay for the portable radios.

Councilman Halliday asked what is impacting volunteers to leave? Grahame responded that it is poor leadership, personality, people moving out of the area, etc.

Councilwoman Crooks:

*This is the same with all 1st responders across the country. Give what is needed for the volunteers. Field Training is needed not virtual.

*There is a Junior Fire Fighter program

Councilman Collura:

*Why are firefighters going to the EMS calls? Grahame-Getting someone there as quickly as possible. 85% of Fire calls are for EMS and 5% fires.

*Offer classes in high School or college to get students interested and have the State pay for classes.

*Require less training hours

Councilman Byrnes:

*Corinth is getting the Radios a few at a time.

ATTORNEY:

*State passed legislation for first responders to receive 10% reduction. He will follow up by sending the information to the Board. Would have to create a local law.

*Blue Waive Solar---Letter of Pilot Agreement received and needs a response in 60 days. A letter for each project was drafted to send back letting them know we would like the Pilot.
