# INCREASING THE TERM OF OFFICE OF TOWN SUPERVISOR FROM TWO YEARS TO FOUR YEARS

WHEREAS, the Corinth Town Board wishes to increase the term of office of the Town Supervisor from two years to four years commencing with the term that begins January 1, 2024, and

WHEREAS, this legislation is authorized in accordance with New York Town Law §24-a, and

WHEREAS, New York Town Law §24-a requires any such change in term be subject to a mandatory referendum at the Biennial Town Election; and

**WHEREAS**, if adopted by the Corinth Town Board such Resolution will not take effect and the terms shall not be extended unless approved by a majority of the voters upon such mandatory referendum at the November 7, 2023 General Election.

NOW, THEREFORE, BE IT

RESOLVED, that the Corinth Town Board shall increase the term of Town

Supervisor from two years to four years commencing with the term that begins January 1, 2024, and

BE IT FURTHER,

**RESOLVED**, that this Resolution shall not take effect and the terms shall not be extended unless approved by a majority of voters upon a mandatory referendum at the November 7, 2023 Biennial Town Election, and

BE IT FURTHER,

**RESOLVED**, that the Corinth Town Board authorizes and directs the Corinth Town Clerk to send a proposition to the Saratoga County Board of Election to be included in the November 7, 2023 Biennial Town Election.

ENACTING A PROPERTY TAX EXEMPTION FOR VOLUNTEER FIREFIGHTERS AND
AMBULANCE WORKERS IN THE TOWN OF CORINTH

WHEREAS, the Town Board has prepared proposed Local Law No.: 1 of 2023 entitled, "A Local Law of the Town of Corinth Enacting a Property Tax Exemption for Volunteer Firefighters and Ambulance Workers Pursuant to Section 466-a of the Real Property Tax Law". Local Law No. 1 would grant a property tax exemption of 10% of assessed value of property owned by an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service; and

WHEREAS, adoption of this legislation is authorized by New York Municipal Home Rule Law §10 and Real Property Tax Law § 466-a; and

WHEREAS, Municipal Home Rule Law §20 requires the Town Board to hold a public hearing prior to the adoption of any Local Law;

## NOW, THEREFORE, BE IT

**RESOLVED**, that the Corinth Town Board shall meet and hold a public hearing beginning at the Corinth Town Hall, 600 Palmer Avenue, Corinth, New York, beginning at 06:00 p.m. on 23<sup>rd</sup>, February, 2023 to hear all interested persons and take any lawful action concerning proposed Local Law No.: 1 of 2023; and be it

**FURTHER RESOLVED**, that the Town Board further authorizes and directs the Corinth Town Clerk to publish and post a Notice of Public Hearing concerning proposed Local Law No. 1 of 2023 in the manner provided by law and to make a copy of the proposed Local Law available for public inspection in the Town Clerk's office following the adoption of this Resolution and until the Public Hearing is closed.
