# RESOLUTION ADOPTING LOCAL LAW NO. 3\_ OF 2023 AMENDING CHAPTER 55 (DOG CONTROL)

WHEREAS, upon recommendation of the Town's Dog Control Officer, the Town Board has proposed Local Law No.:3 of 2023 entitled, "A local law amending §55-10 regarding seizure, impoundment, redemption and adoption of dogs"; and

WHEREAS, adoption of this legislation is authorized by New York Municipal Home Rule Law §10; and

**WHEREAS**, a public hearing was held on the 13<sup>th</sup> day of July, 2023, at which time all persons desiring to be heard were heard, and due consideration was had thereon by the Town Board:

NOW, THEREFORE, BE IT

RESOLVED, that the Corinth Town Board adopts Local Law No.: 3 of 2023; and be it

**FURTHER RESOLVED**, that the Town Clerk is authorized and directed to file the local law in the form annexed hereto with the NYS Secretary of State forthwith.

# Local Law No.3 of 2023 AMENDING 55-10 REGARDING SEIZURE, IMPOUNDMENT, REDEMPTION AND ADOPTION OF DOGS

ARTICLE 1. Chapter 55 of the Corinth Town Code is retitled "DOG CONTROL, and is amended by the addition of a new Paragraph D to §55-10 which reads in full:

In the event a dog is turned over by a law enforcement officer to the Town of Corinth Dog Control Officer for reasons of safekeeping, and when no other violation of this Chapter exists, and when such law enforcement officer is unable to find suitable care for the dog, the Dog Control Officer may shelter such dog for no more than seven days from the date of receipt of the dog from such law enforcement officer. If the seventh day falls on a day where the owner is unable to redeem the dog but the shelter housing the dog is closed, the owner shall be given until the next business day to redeem the dog. The owner shall pay a \$25 administration fee, per dog, to the Town, plus the prevailing charge per shelter under the Town's agreement with the shelter. If the owner does not redeem the dog and pay all fees associated with the dog's impoundment by the close of business of the shelter on the final redemption day, such owner shall have thereby released ownership of the dog to the Town for adoption or euthanasia. The owner shall be responsible for all fees and costs incurred by the Town.

ARTICLE 2. The invalidity of any clause, sentence, paragraph or provision of this Local Law shall not invalidate any other clause, sentence, paragraph or part thereof.

ARTICLE 3. All Local Laws or ordinances or parts of Local Laws or ordinances in conflict with any part of this Local law are hereby repealed.

ARTICLE 4. This Local Law shall take effect upon filing in the office of the New York State Department of State

Notice of Public Hearing Town of Corinth

The Town of Corinth will hold a public hearing on July 13, 2023 @6:15PM for the purpose of hearing public comments on the 2023 Town of Corinth's community development needs, and to discuss the possible submission of a Mobile and Manufactured Home Replacement Program for the 2023 program year. The CDBG program is administered by the New York state Office of Community Renewal (OCR) and will make available to eligible local governments approximately \$10,000,000 for the 2023 program year for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefitting low/moderate income persons. The Town of Corinth is applying for \$600,000 of CDBG funding to replace income-eligible owner-occupied, singlefamily mobile homes, on their own land, located within the Town. The hearing will provide further information about the proposed Mobile and Manufactured Home Replacement Program and will allow for citizen participation in the development of any proposed grant applications and/or to provide technical assistance to develop alternate proposals. Comments on the proposed project will be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

The Corinth Town Offices are accessible to persons with disabilities.
