*Planning Board Chair Dave Barrass updated the board on planning board activity. Things are going smoothly, good board members, staying busy.

*Currently working on The Foothill Builders major subdivision on Main St. They have fulfilled all the Town requirements and concerns. Water System needs to be approved by the Village which is still in process. Due to the size of the development it also needs to be approved by the Department of Health. The Town Planning Board has approved the development on the condition that both the Village and Department of Health approve. If anything needs to be changed, Foothill Builders would need to come back to the Town Planning Board.

*Jason Crowl would like to subdivide. Can not move forward until the deed has been filed. Part of the property is commercial and the other is residential. This would require the Town Board to approve a Boundary Line Adjustment. The Attorneys should be able to help with this process.

STACEY MARTINEZ-DCO:

Stacey Thanked everyone. Spent 2 days in Albany at a conference. Learned a lot. In the first 45 days-8 dog bite cases, 13 total right now. Cats 3 calls since February. Busier than thought it would be. A discussion was held regarding DCO being required to handle cats- it is not required by law to do so and is up to the DCO. Stacey would like to educate the residents on how to break up a dog fight and how kids should handle strange dogs. The last dog bite case took 12 days to figure out who owned the dog. Stacey stated that Joel-deputy DCO is very helpful.

Jennifer Michelle: Asked about mowing on Locust Ridge Dr. ---Highway Superintendent Eggleston stated that no one on his crew has been out there mowing.

TOWN BOARD: Councilwoman Crooks:

*Revitalization efforts—ATV roads and trails. NYS is against this, but Local Laws could allow it within the Town. The Town could pass a local law with a permit system. Will talk with local snowmobile clubs to see if they may be interested in letting us use the trails. This is something to consider. Other small Towns have had huge draws to their communities by doing this.

Public: Jennifer Michelle was concerned about the noise and for those that walk their dogs on those trails.

*Would like the Town Board to discuss starting a Fire District. A lot of benefits. The Town Board would need to vote just to start the discussion and the Village Board would need to do the same. Councilwoman Crooks asked for a motion to start the discussion. The board decided to wait until it is discussed with the Town's Attorney and Supervisor Butler & Councilman Halliday have met with the Village. The board will revisit this topic at another time.
