**WHEREAS**, the Town Board wishes to increase the maximum income level and associated income level sliding scale for the partial exemption on real property taxation for eligible persons sixty-five (65) years of age or over; and

**WHEREAS**, adoption of this legislation is authorized by New York Real Property Tax Law §467 and New York Municipal Home Rule Law §10; and

**WHEREAS**, the Town Board duly held a Public Hearing concerning such proposed Local Law on Thursday, February 8, 2024 and heard all interested persons,

## NOW, THEREFORE, BE IT

**RESOLVED**, that the Corinth Town Board hereby adopts Local Law Number 2 of 2024 amending Town Code §116-6 to increase the maximum income level and associated income sliding scale for the partial exemption on real property taxation for eligible persons sixty-five (65) years of age or over; and be it

**FURTHER RESOLVED**, that the Town Board hereby authorizes and directs the Town Clerk to file the Local Law with the New York Secretary of State in accordance with the provisions of the Municipal Home Rule Law and acknowledges that the Local Law will take effect immediately upon filing by the Office of the Secretary of State; and be it

#### EMS:

EMS Coordinator Fogarty asked for permission to apply for an AFG Grant which opens on Jan. 29<sup>th</sup> and closes on March 8<sup>th</sup>. He would like to write the grant for 3 cardiac monitors. The cost per monitor is \$40,000.00. The Town purchased 3 monitors 10 years ago using the same grant. The total for the Town would be 5% match -- approximately \$6000. It is a competitive grant with about 2000 Grants awarded. The Town of Greenfield could also apply for a grant. Would be looking for an ambulance but would need to discuss this with the Town of Greenfield. The Cost to the Town would be approximately \$15,000 for the ambulance.

Supervisor Butler stated that the EMS has a flat line budget. Has had no increase to tax-payers in 3yrs. The service supports itself. There is a fund balance that could be used for the 5% match.
