RESOLVED, that the members elect from their own a chairman and secretary of the Youth Commissions which will serve for one (1) year; and be it further

RESOLVED, that such Youth Commission has the power to adopt rules of procedure for the conduct of their business; and be it further

RESOLVED, that the Town Board hereby authorizes and directs the Town Supervisor, Town Clerk and other appropriate Town Officials to take any action necessary to effectuate the intent of this Resolution.
