RESOLUTION ADOPTING LOCAL LAW NO. 1 OF 2025

AMENDING CHAPTER 91 OF THE CORINTH TOWN CODE REGARDING OCCUPANCY OF TRAVEL TRAILERS AND ITS ENFORCEMENT PROVISIONS

WHEREAS the Town Board wishes to enact a Local Law to regulate the overnight occupancy of Travel Trailers within the Town in order to preserve, protect and promote the public health, safety and welfare of the residents, and to enhance the enforcement and penalty provisions of Town Code Chapter 91; and

WHEREAS proposed Local Law No. 1 of 2025 in the form annexed hereto has been proposed by the Corinth Town Board and made available for public inspection; and

WHEREAS the Board duly held a Public Hearing on proposed Local Law No. 1 of 2025 on October 9, 2025 and heard all interested persons;

NOW, THEREFORE, IT IS

RESOLVED that the Board hereby adopts Local Law No: 1 of 2025 amending Chapter 91 of the Corinth Town Code regarding occupancy of travel trailers and its enforcement provisions in the form attached hereto; and it is further

RESOLVED that the Board hereby authorizes and directs the Town Clerk to file the Local Law with the New York Department of State in accordance with the provisions of the Municipal Home Rule Law and acknowledges that the Local Law will take effect immediately upon filing by the Department of State.

LOCAL LAW NO. 1 OF 2025

A LOCAL LAW AMENDING CHAPTER 91 OF THE CORINTH TOWN CODE REGARDING OCCUPANCY OF TRAVEL TRAILERS

AND ITS ENFORCEMENT PROVISIONS

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF CORINTH, SARATOGA COUNTY, NEW YORK, AS FOLLOWS:

SECTION 1. PURPOSE AND INTENT

The purpose and intent of this Law is to amend Chapter 91, Part I, Article III, §91-6 regarding occupancy of travel trailers outside of a travel trailer camp and to amend Chapter 91, Part 1, Article VIII, §91-48 regarding enforcement and penalties.

SECTION 2. AMENDMENT OF CHAPTER 91, PART 1, ARTICLE III, §91-6

Chapter 91, Part 1, Article III, §91-6 of the Corinth Town Code entitled "Permit required" is hereby repealed and replaced with the following:

- A. It shall be unlawful for any person, partnership, association or corporation to locate a mobile home or to construct, alter, use or allow the use of any mobile home park or travel trailer camp within the limits of the Town of Corinth, unless a valid permit has been issued by the Town Board. Permits for mobile homes and mobile home parks are effective from the day of issuance to and including December 31st of the same year.
- B. No permits are required for the placement and/or occupancy of a travel trailer outside of a travel trailer camp. However, overnight occupancy of a

travel trailer outside of a travel trailer camp shall only be allowed from May 1st through September 30th of each year. Overnight occupancy of a travel trailer outside of a travel trailer camp is prohibited from October 1st through April 30th each year. No travel trailer outside of a travel trailer camp may be parked and occupied overnight for more than 14 consecutive days in the same location.

SECTION 3. AMENDMENT OF CHAPTER 91, PART 1, ARTICLE VIII, §91-48

Chapter 91, Part 1, Article VIII, §91-48 of the Corinth Town Code entitled "Penalties for offenses" is hereby renamed "Enforcement and Penalties" and repealed and replaced with the following:

- A. Any person, persons or entity who shall violate any provisions of this Part 1, or any person, persons or entity who owns real property upon which a violation of this Part 1 has occurred shall be guilty of an offense punishable by a fine not exceeding \$250 per day or imprisonment for a period not exceeding 15 days, or both. Each day's continued violation shall constitute a separate offense.
- B. Any person, persons or entity who shall violate any provisions of this Part 1 or any person, persons or entity who owns real property upon which a violation of this Part 1 has occurred shall be liable for civil penalties in the amount of \$250 per day. Each day's continued violation shall constitute a separate violation.
- C. The Town for Corinth Building Inspector/Code Enforcement Officer may bring criminal or civil proceedings in Town Court for enforcement of this Part 1.
- D. The Town of Corinth may seek injunctive relief, civil penalties and any other relief available to enforce the provisions of this Part 1 through commencement of an action in the New York State Supreme Court. Such action must be authorized by a Resolution of the Town Board.
- E. The enforcement and penalties set forth herein are not exclusive and may be sought cumulatively.

SECTION 4. SEVERABILITY The invalidity of any clause, sentence, paragraph or provision of this Local Law shall not invalidate any other clause, sentence, paragraph or part thereof.

SECTION 5. REPEALER All Local Laws or Ordinances or parts of Local Laws or Ordinances in conflict with any part of this Local Law are hereby repealed.

SECTION 6. EFFECTIVE DATE This Local Law shall take effect upon filing in the office of the New York State Secretary of State.

WHEREAS, Municipal Home Rule Law §20 requires the Town Board to hold a public hearing prior to the adoption of any Local Law,

RESOLVED, that the Corinth Town Board shall meet and hold a public hearing beginning at the Corinth Town Hall, 600 Palmer Avenue, Corinth, New York, beginning at 06:00 p.m. on Thursday, October 23, 2025, to hear all interested persons and take any necessary action provided by law concerning proposed Local Law No.: 1 of 2025, and be it
