FIRE CONTRACT OFFER: Councilwoman Denno stated that she and Supervisor Butler met with Village Mayor Miller and Village Trustee Clark to discuss the Fire Contract. At the end of the discussion the village came back with an offer of \$450,000. Councilwoman Denno stated that this was extremely well done.

Councilwoman Crooks asked if there was any conversation on a fire district? Reply: No, the discussion stayed on this Fire Contract.

Supervisor Butler stated that this was a show of good faith. The original offer was \$525,000 the Town counter offered \$420,000, which the Village refused and stuck with \$525,000, however at this meeting the \$450,000 was offered. Both Councilwoman Denno and Supervisor Butler agreed to take this number back to the Town Board.

**ATTORNEY ITEMS:** Reminder to review the Proposed Travel Trailer Law prior to the Public Hearing on October 9, 2025.

#### **SUPERVISOR ITEMS:**

\*RJMA grant writer renewal—Cost \$38,608 total paid in quarterly increments of approx. \$9652. This is an increase from last year of \$4,100. Councilwoman Crooks stated that is a good investment considering that the Town received around 700K in grants for this year. The remaining Town Board members agreed.

#### **TOWN CLERK:**

The Highway department is looking to put out a Notice to Bidders for a Single Axle Cab And Chassis, Plow, Tilt Frame and Mounting Plates, 10' Stainless Steel Combination body, Hydraulics, Mounting Hardware and Controls. The funds would come from the 2025 budget, 2026 budget and Fund Balance.
